TO THE HONORABLE, THE JUDGES OF THE UNITED STATES AIR FORCE COURT OF CRIMINAL APPEALS:

Submission of the Case Without Specific Assignments of Error

On 5 May 2023, Airman (Amn) Tyrone Gammage, Appellant, assigned as error that his Record of Trial was incomplete because it omitted the attachments to Prosecution Exhibit 1, the stipulation of fact. Order, 5 June 2023. On 30 May 2023, the Government agreed in its Answer that Amn Gammage's case should be returned for correction in accordance with R.C.M. 1112(d). *Id.* On 5 June 2023, this Court returned Amn Gammage's case to the Chief Trial Judge, Air Force Trial Judiciary, for correction under R.C.M. 1112(d) to account for eight missing attachments to the stipulation of fact. *Id.* On 23 June 2023, Amn Gammage's case was docketed with this Court for further review after a certificate of correction, dated 21 June 2023, was filed with this Court. Notice of Docketing, 23 June 2023; Certificate of Correction, 21 June 2023.

On 18 August 2023, Amn Gammage assigned as error that his corrected Record of Trial was incomplete because on further review, the attachments to the stipulation of fact did not match what was stated on the record. Br. on Behalf of Appellant, 18 August 2023, at 3, 7. Amn Gammage further assigned as error that the Government's submission of an incomplete record does not toll the presumption of post-trial delay under *United States v. Moreno*, 63 M.J. 129 (C.A.A.F. 2006). *Id.* at 9-13.

On 25 September 2023, the Government filed its answer, agreeing four photographs were missing. United States Answer to Assignments of Error, 25 September 2023. On 29 September 2023, this Court returned Amn Gammage's case to the Chief Trial Judge, Air Force Trial Judiciary, for correction under R.C.M. 1112(d) to account for missing photographs that were part of Attachment 6 to the stipulation of fact. Order, 29 September 2023. Amn Gammage's case was docketed with this Court again on 13 October 2023. Notice of Docketing, 13 October 2023. A certificate of correction now states the version of Attachment 6 that is attached to Amn Gammage's record is the correct attachment that was provided during the court-martial, and it was inaccurately described on the record. Certificate of Correction, 12 October 2023.

The undersigned appellate defense counsel attests she has, on behalf of Amn Gammage, carefully examined the record of trial in this case, including the Certificate of Correction, dated 12 October 2023, and its attachment. Amn Gammage submits this case to this Court on its merits with no specific assignments of error at this stage of appellate review.
